State law requires that no more than half of the election judges in a precinct can be members of the same major political party. **Therefore, election judges are asked to declare a major political party affiliation.** Once assigned to a polling location, however, when working at the polling place, election judges must remain nonpartisan.

*An individual who is selected as an election judge may be absent from a place of work for the purpose of serving as an election judge without penalty if they notify their Employer at least 30 days prior to each election. (M.S.204B.195). The City of New Germany pays each Election Judge \$10.00 per hour for training and Election Day activities (Head Judge paid \$10.50 per hour).*
