## 2. Approval of Agenda

Consider Approval of Agenda – Jaeger, moved and Mielke second approving agenda. The motion carried. 5/0

Joe Lemmerman – Car Show special permit to extend until September 28, 2023. **Jaeger moved and, Mielke second. The motion carried. 5/0** Joe Lemmerman gave an update on Oktoberfest, October 20-21, 2023; Jim Strehlke will be playing from 7 pm – 10 pm on Friday night, from 10 PM – 12 PM. Jim would like to play the movie Hermantown. **Jaeger moved and, Mielke second approving the movie night. The motion carried. 5/0**

#### 5. Officers'/Department/Staff Reports

- Waste Water Engineer Jessica Hedin went through the estimate for wastewater predesign activities;
   Topographical survey, Archeological survey, Soil investigation, Geotechnical report and ground water
   monitoring. This also places the city in a better position for funding from a bonding perspective. The cost
   associated with these tests is \$38,497.00, with SITU quote of \$5,197.40, City would pay SITU directly.
   Grove moved, Mielke second approving the SEH estimate for the predesign activities. The
   motion carried. 5/0
  - Bonding Bill we will present to the bonding bill committee on October 10, 2023 at Cologne, 10 AM. Jessica went through the strategy we will be used for presentation. Will continue to pursue other sources of funding, applications for ear marks, keep submitting for funding.
- Financial Advisors Dan with Ehlers was present to discuss the 3 options for the interfund loan for the new fire truck. All situations the city is paying itself interest. Council had a discussion on the options; option 4A is all interfund loan from the general fund \$290,000, Option 4B is \$200,000 interfund general fund and the rest coming from the FD capital fund, option 4C \$145,000 interfund general fund loan, rest is from the FD capital fund. Council weighed the financial impact on the city and townships, continued discussion with Ehlers. Grove moved and, Mielke second approving option 4A. The motion carried. 4/1

- Fire Department Report Carver County hearing was cancelled for the Fat Boyz gambling funds theft; was to be in August, at this time it is unknown when it will be rescheduled. September 17 is the deadline for repayment to the MN Gambling Association, in the amount of \$11,134.00. Chief Goede questioned if the City would write a check from the FD capital fund to the Relief. Special Meeting on September 12, 2023, 7 PM, if Relief cannot pay.
