5. Officers'/Department/Staff Reports

- Fire Department Report
 - \$10,000 donated from NG Relief Association (Resolution 2023-20), to FD truck/building capital fund. NG Relief donated \$13,195., to the Parks Capital fund (Resolution 2023-21), NG Relief donated \$906., for the Super Sopper (Resolution 2023-22).
 - Dan Derusha went to court on pull tab Fat Boyz theft, court was canceled and rescheduled until December 1, talk with County Attorney for compensation of lost wages.
 - Accident billing has collected \$5,490.
 - Expensive repairs on FD trucks, to complete the remaining repairs is an additional \$5,900.
 - o Cascade system fixed twice, had leaks, up and running again.
 - Everyone is going to the 6,000 radios, would be capable of the encryption, quote for 3 radios was over \$17,000, other radios would have been \$14,000., discussed budget amount and what type of radios to purchase for this year, programming is another \$1,500.

- Found used 2021 GMC Sierra Utility vehicle in St Cloud, utility box and lights already on it, \$118,000., skid unit would be needed. FD is keeping their eyes and options open for used fire department vehicle, FD Capital Fund has approximately \$342K., most likely would sell the van. Council recommends checking where the used GMC came from.

- Public Works street sweeping yesterday, County possible tomorrow on county roads 30/33.
- Clerk Report
 - Soil boring at Wastewater ponds next Tuesday.
 - SEH is getting a permit from the Carver County (connects on 30), for the ally storm drain project.
 - New carpet in Hall will be installed on November 13th.
 - Sent new ordinances to the codification company, they will complete the supplement sheets and send back to be placed in the city code book.
 - Budget is solid, if there is a need to move funds around for snow plowing, we can do this by Resolution if and when needed.
