- County Commissioner John Fahey
  - Highway 212 update, open Bongards bridge by middle of November for North/South travel. Ground problems on Bongards' east side continue to cause subsidence, resulting in instability. Because of these difficulties, the project's completion will be delayed by several months beyond the planned November deadline. Switch lane construction is in progress, so please slow down and proceed carefully through the area. This has been the largest project in Carver County.
  - Highway 5 project is undergoing and will be more coming for the future. Victoria will have construction and not be favorable for commuting, multiple shutdowns when the project starts.
  - County Road 40, also known as East Union toward Belle Plain and referred to as Deadman's Corner along the Minnesota River, has seen mostly motorcycle accidents. The project is complete, although a few final tasks remain outstanding.
  - O CarverLink operates in multiple Townships in partnership with Metronet.
  - Healthiest county for the 4<sup>th</sup> year in a row.
  - Commissioner Fahey provided updates on the Carver County Library and the Regional Railroad update.
